PROPOSAL FOR 'A SPORTING WOMAN' [working title]

The story centers on Heed and Christine Co^Sey, two women who grew up together as best friends but not related. They now live in searing mutual contempt in a house of which both claim ownership. How they moved from inseparable love to inextricable hatred is tracked throughout the narrative.

Into the chill of women who do not speak to each other comes a lovely young woman answering an advertisement for a personal assistant. Heed placed the ad; Christine knows nothing about it. Reasonably, at first, interested in improving her financial status, the young woman quickly discovers more and other ways of accumulating gain. Chameleon-like she adjusts to the needs of Christine's personality and complaints as well as to Heed's demands and frailties. She makes herself indispensable, taking control by offering each the illusion of asserting power. Ferreting out their secrets, their hidden papers, their vulnerabilities and vanities, she is able to assume complete control over their lives with no witnesses and no one to stop her, except a teenaged boy who does lawn and house chores for them . He is from the surrounding neighborhood—made up of neat modest houses spreading out on land sold by the original Co^Sey. It is he who finds himself in a position to rescue (or not) Heed and Christine, and to discover more of the history of the Co^Sey family.







Early in their marriage, Cosey takes Heed to places where he took his son. She doesn't know how to dress and Cosey can't tell her because he doesn't know either. [her high heeled shoes don't fit and she can't walk well in them; etc.] They are mistaken for father and daughter or granddaughter, and the embarrassment makes Heed reluctant to continue these outings. See L's description of where Cosey takes Billy Boy: baseball games, jam sessions et al. [place in barber chair scene]

Christine is jealous of these outings. When she invites herself to one, May refused to let her go. [Heed is cheered that Christine might go too; both girls sad that it was not possible. Don't understand May's "How would that look? How? Where would you sleep?" But she never confronted her father in law about the unseemliness—so the girls thought their inquiry was their own stupidity. [place in scene where Christine nears the hotel—looking for Heed and Junior ?—as she approaches the front door, remembers standing there while Cosey and Heed drove off]

At restaurant where Christine finds a job, she is steeped in and bored by the gossip of the workplace involving the owner, the cashier, the owner's wife and perhaps a short order cook. All of it demanding alertness, interpretation, malice and instant judgment. Exhausted also by the drift of the conversations between herself and her married boyfriend. [she doesn't really care whether he separates or not, sleeps with his wife or not, makes her pregnant or not, gives her a lesser Christmas present or not—but since they have no friends in common, there is nothing else to talk about—"level of affection" and threats of dissolution were all.] It was only an outline of a life, a doodling on a paper napkin yet to be filled in while she purposefully stayed away from the home May described in letters. Into that aimlessness comes Fruit with a canvas satchel and a beautifully ironed work shirt. He didn't like red gravy or sauce on his fish. What he said was, "Don't hide it. If it's worth eating it's worth looking at." Looking straight into her eyes.

Notes and recollections re: Untitled

1. Cosey's relationship with his son Billy: tight, his supreme love. Why? Because of his non-relationship with his own father [who never spoke to him, but left him 114,000 resentful dollars]. So Bill Cosey is spendthrift; and lavishes affection and companionship on his own son. In a way becoming the boy: dressing alike, taking him to places he himself loves, bragging on him, etc. When Billy dies, [at 25, in 1935] everything changes for Bill Cosey: has no "mirror". Begins to love and capture things his son liked along with certain items that were important to that relationship. I.e. The barber shop chair that Billy and he sat in—this he buys and puts in his bathroom. Begins an affair with the girl from whose face Billy Boy removed a fish hook—the girl is 20 years old now. When she leaves town for war work in 1941; Bill Cosey takes to meditating, musing on the "alter" of Billy's things in his bedroom; leaving the room one day in 1942 he sees a little girl walking down the hall in a yellow bathing suit, shaking her butt to the hotel music. He is aroused and speaks to her. Later he fondles himself at the window of his granddaughter's room. That same year, the Johnson children drown on Cosey's beach. He visits the family, pays for the funeral, gives them presents. Returns and asks for the little girl's hand in marriage—for which he gives her father a certain amount of money. His relationship with this child bride is careful: she is "not a woman" yet, so for two years he only "plays" with her. (This may be a kind of trans-gender indulgence: her chest is flat, young muscle tone, grateful for presents, docile and rough at the same time,—almost like roughhousing with his son when he was little—without the sexual component.) Has casual affairs with local women including woman at the crab factory. When sex begins with his bride (she is 13) things settle down a bit [he buys land and builds big house on Post? Road and he puts her more in charge of hotel. Strife among the women intensify until it explodes when his granddaughter comes home from boarding school (in 1946). In 1947, Celestial returns and his relationship with her is re-ignited. Stays active until he dies and he leaves her everything in his will. Query: how does Billy Boy die? Does his father feel guilt?

2. L knows about Celestial, remembers his relationship with his son; knows about his cold relationship with his own father; is disturbed by his true will. Loves him almost unconditionally, "purely"; joins Celeste at his grave-side at the end. And hums.

3. While Bill Cosey is playing out his fantasies with his son [transposing that worship into other relationships, esp. Celestial], the women around him are deeply affected: Christine feels deposed, ignored, thrown away; also is confused by the disgust and pleasure her grandfather introduced her to when she saw him masturbate at the window of her bedroom. Violently affected by her mother's insistence on enmity with her childhood friend [which was her only chance for the stability of a like-minded friend etc.] Heed, is thrown into center of a family dispute—May and Christine*—and into the malice of the townspeople at the undeserved status Cosey has given her. At sixteen, when Christine returns, she has not yet gotten pregnant; believes that is why her husband is disappointed in her. [The truth is, he is sterile, Celestial has returned, and he is tired of the bickering among the women. His pleasure now is in the Hotel, its camaraderie, his escapades on his fishing boat, and Celeste.] May is consumed by the displacement of herself by Heed in the running of the Hotel. Translates part of that fear of displacement into a rabid hatred of Civil Rights—another displacement, another threat to the status quo. *she has won*

4. Sandler knows the libertine Cosey and the boat parties and about the special relationship with Celestial. Heed knows the financial problems Cosey had during the late sixties, when business slackened and Cosey had to borrow money from the Sheriff. [Only the threat of the boat party photographs keeps the Sheriff's son from collecting]. She also learns (via an aborted pregnancy with an erstwhile lover—who abandons her—)that it is not she who can't have children. Her relationship with Cosey is stoic: she works hotel, secures in his protection and status, grows haughty, rivals everybody and loses the kind of person she should have would have been.

5. Junior enters into this cauldron with no agenda except survival but develops one when she gets the lay of the land. She and Romen become another set of odd-aged couples? She gloms onto the portrait of Cosey and turns him into the G.I. Joe father she never knew. The protector who lets her have her way. And who supports her opportunistic plan to take over the house with a hope of owning it and having Romen at her side.


